

TARIFF OF FEES AND COMMISSIONS

I. In Chapter One – for Individuals and Chapter Two – for business clients: „Cash transactions under the Law on the Introduction of the Euro in the Republic of Bulgaria in the period from 03.08.2026 to 31.12.2026 “		
1.	Cash deposits in leva at the official exchange rate (1.95583 leva for 1 euro) by the account holder to their euro account, including accounts converted from leva to euros, opened with Fibank	free of charge
2.	Counting when depositing Bulgarian coins in cash	free of charge
3.	Cash exchange of leva into euros at the official exchange rate (1.95583 leva for 1 euro)	0.1% of the deposited amount, min. EUR 0.51/BGN 1
3.1.	Counting of BGN coins at cash exchange to euros	5% of the amount, min. EUR 5.11/BGN 10
3.1.1	for Fibank's customers	free of charge
4.	For deposits/exchanges of amounts over 30,000 leva, a prior request is required of 3 (three) working days	

Note: The commission for counting of coins in case of cash exchange (Item 3.1.) shall be collected in case of cash exchange of coins more than 20 items (total of all) regardless of their face value including when the cash exchange is mixed (of banknotes and coins). This commission shall be accrued on the whole amount of the exchanged coins and shall be additionally paid to the commission under Item 3).

II. Effective **01/07/2026** in Chapter One – for Individuals and Chapter Two – for business clients, are introduced:

1. In Section III. Purchase and sale of foreign currency, Art.1, Item 2.1:

“Counting of EUR coins at cash exchange” - 5% of the amount, min. EUR 5.11/BGN 10

Note: The commission for counting of EUR coins at cash exchange (Art.1, Item 2.1.) shall be collected in case of cash exchange of coins more than 20 items (total of all) regardless of their face value including when the cash exchange is mixed (of banknotes and coins). This commission shall be accrued on the whole amount of the exchanged coins and shall be additionally paid to the commission under Art.1, Item 2.
