RULES FOR

PROMOTIONAL CAMPAIGN "EUROCOSMOS" OF FIBANK "NO FEE FOR DEPOSIT OF CASH IN BGN FOR SAVINGS PRODUCTS IN BGN AND EUR"

1. CAMPAIGN

- 1.1 The campaign is organized and conducted by First Investment Bank AD, UIC: 831094393, having its registered office and address of management in Sofia City, 111P Tsarigradsko Shosse Blvd. (hereinafter referred to as "Fibank" or "the Bank", or "FIB", or "Organizer").
- 1.2 The campaign is conducted in accordance with the terms of these Rules (hereinafter referred to as "Rules"), which are also valid for the campaign "EUROCOSMOS".

2. DEFINITIONS

For the purposes of these Rules, the terms set out below shall have the following meaning:

2.1 "CASH DEPOSIT IN BGN" is:

- 2.1.1 cash deposit of banknotes in BGN into a savings product account in BGN or EUR specified in item 2.2. in Fibank, which is carried out personally by the individual, account holder, or by their proxy, legal representative.
- 2.1.2 cash deposit of banknotes in BGN into a savings product account in BGN or EUR in Fibank with a minor as the holder of bank account, which is carried out by the legal representative of the kolder or by the holder (a person aged 14 to 18, with the consent of their legal representative parent, guardian), or by an individual, client of Fibank.
- **2.2 SAVINGS PRODUCT IN BGN AND EUR** for the purposes of this campaign shall be term deposits, savings accounts and demand deposits in BGN and EUR with the Bank new or already opened.

The terms of the campaign do not apply to "For me" deposit and "Express" deposit.

2.3 "OFFICIAL EXCHANGE RATE OF THE BNB FOR BGN/EUR" - is the official exchange rate of the Bulgarian National Bank /BNB/ of the Bulgarian lev to the Euro, published on the official website of the BNB - www.bnb.bg.

3. RULES OF THE CAMPAIGN

3.1 The rules have been prepared in accordance with the requirements of Bulgarian legislation and will be published on the website of Fibank - www.fibank.bg, where they will be available throughout the campaign period in a manner that allows their storage and reproduction.

3.2 For issues not regulated in these Rules, the applicable Bulgarian legislation shall apply.

4. CAMPAIGN PERIOD

4.1 The campaign shall be held in the period: 06.06.2025 - 31.12.2025, inclusive.

5. CAMPAIGN MECHANISM

- 5.1 When depositing banknotes in BGN into a savings product in BGN and EUR by the persons under item 2.1, the Bank shall not charge a cash deposit fee, and for the exchange rate, when the account is in EUR, the Official Exchange Rate of the Bulgarian National Bank for BGN/EUR shall be applied.
- 5.2. For all other fees and commissions that do not fall under item 5.1., the Tariff for fees and commissions of Fibank AD shall be applied.

6. TERMINATION OF THE CAMPAIGN

6.1 Fibank shall have the irrevocable right to terminate the campaign at any time, before the end period, regardless of the reason, as well as to make changes to the rules of the campaign. In these cases, the participants are not due compensation. The changes shall be announced in an appropriate manner on the Fibank website www.fibank.bg. Changes or termination of the Campaign shall enter into force from the moment of their publication on the Fibank website at www.fibank.bg

7. LIABILITY

7.1 Fibank shall not be liable and cannot be involved as a party in legal proceedings related to the inability to participate in the campaign.

8. PERSONAL DATA

8.1. Fibank is a personal data controller and processes personal data in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27.04.2016 ("General Data Protection Regulation").
